

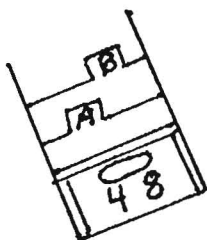

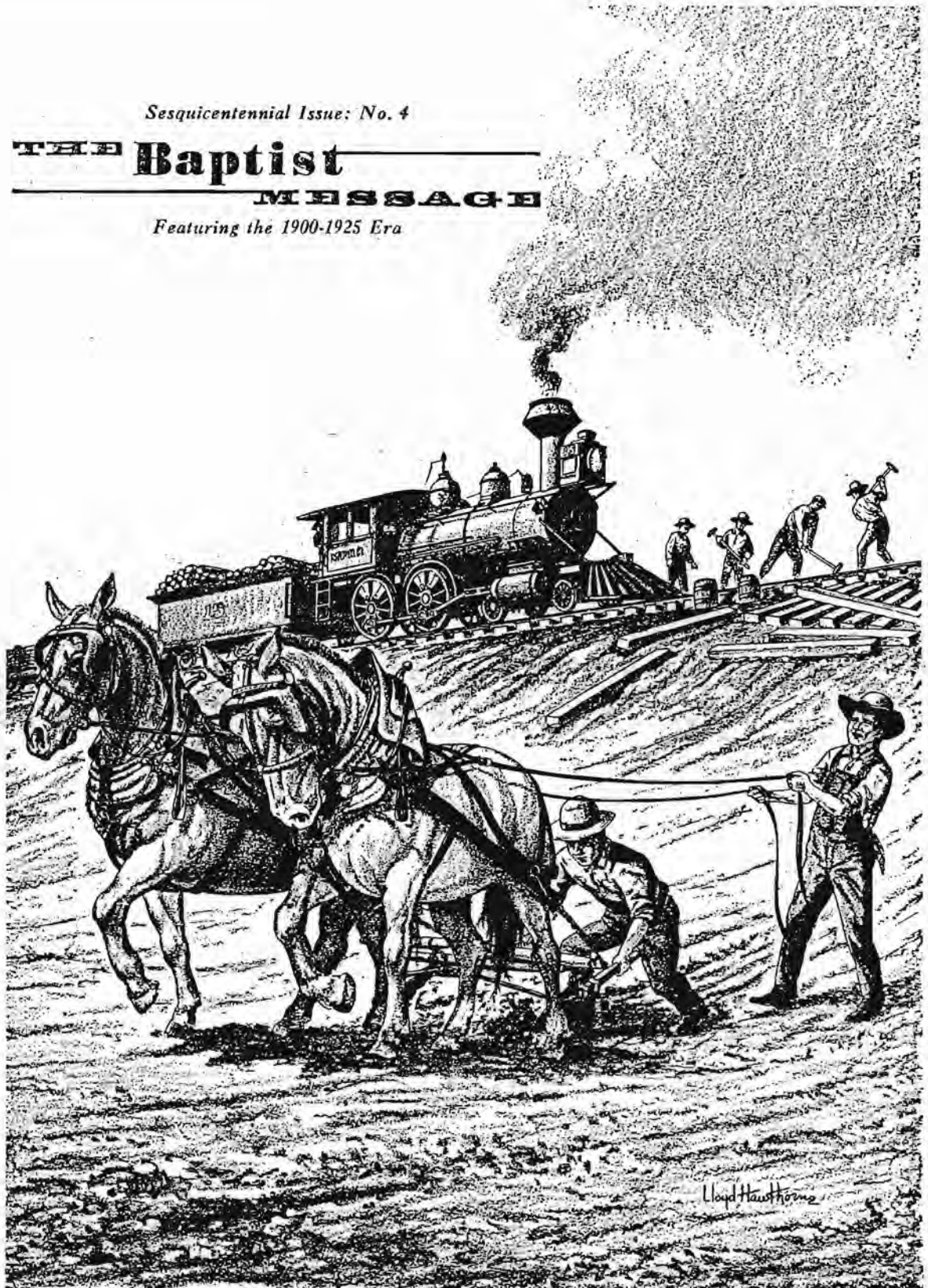

Edition No. 4: 1900-1925 A TIME OF CHANGE: The 1900-1925 era can best be characterized as one of the changes brought about by spectacular scientific advances.

As we trace the progress of our spaceship traveling toward Venus, it seems almost unbelievable that many of our readers have witnessed the introduction of the electric light, airplane, motion picture, radio, telephone, television, and the automobile. Yet it is true, as the affirmative nods of many who read these words will testify.

Of these innovations, none has played a more significant role in reshaping America than has the automobile.

At the turn of the century the automobile was such a rarity that Barnum and Bailey displayed a "horseless carriage" as one of the main oddities of their famous circus. Before the end of the era, the automobile was firmly established and was changing the social and economic structure of the nation.

Also contributing to the social and economic revolution of the era was the booming lumber industry. As the industry chopped and sawed its way through the towering virgin forests, new towns, new jobs, new railroads, and new highways were created.

The era was also one of change for Baptists. In 1900 there were only eight full-time, self-supporting churches in the state. These were Coliseum Place, New Orleans, Crowley, Evergreen, Shreveport First, Monroe First, Mansfield First, and Valence Street, New Orleans. Most of the churches had preaching only once a month.

By 1925 the number of full-time churches had greatly increased and membership had risen to 130,000 from the 35,000 of 1900.

Another significant development of the era came in May, 1925, when M. E. DODD, pastor of the Shreveport First church and chairman of the Future Program Commission of the SBC, stood before the Southern Baptist Convention in Memphis to recommend that the Cooperative Program be adopted. The adoption of his recommendation has given increasing strength and stability to all Baptist work.

Executive Secretary W. N. JOHNSON, writing in a 1907 Baptist Chronicle, graphically described the almost electric excitement of the era:

"The supreme hour for Louisiana Baptists is now striking. Our cities are growing by leaps and bounds. New towns are springing up like magic. An era of railroad building is upon us... our day at last seems to be upon us."

Mistaking the dawn of an era for the sunset, an employee of the United States Patent Office is said to have resigned during this period because he felt no significant new inventions were possible. Although the story is probably apocryphal, it points up the tremendous scientific advances of the time.

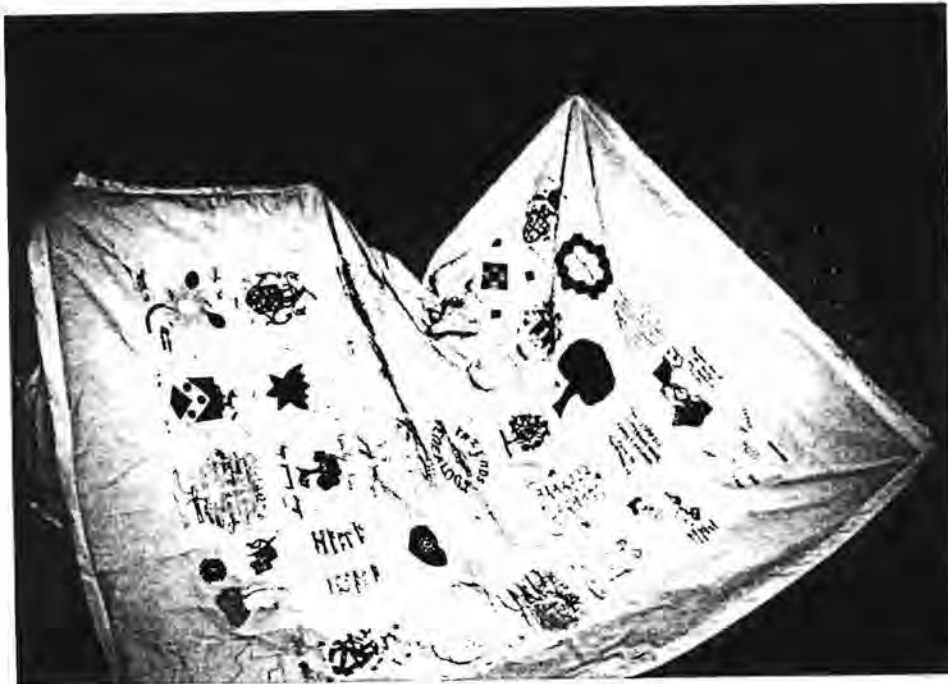
This feeling of confidence in man and science seemed to be characteristic of the entire western world during this period. In Southhampton, for instance, the keel for an "unsinkable" steamship was laid in 1910. When the Titanic carried 1,517 with it to a watery grave two years later, many once again realized that man and science are not invincible nor infallible. God, after all, is the sole possessor of these attributes.

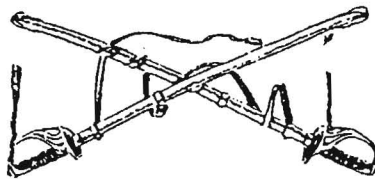

## THE CADDO GUARDS

George L. Woodward, a member of the Shreveport Grays and a native of Caddo Parish, Louisiana, composed his recollections concerning the various volunteer groups from Shreveport and Caddo that saw service in the Confederacy. Mr. Woodward was recorded as one of the surviving members of the Confederate Veterans in 1912. In his summaries, Mr. Woodward mentioned that Capt. William Robson commanded a company from Caddo, a part of the 25th Louisiana Volunteer Infantry.

The following is brief history of the formation of that group and a listing of the men who served with it. The article was found in the General Leroy Stafford Camp #3, United Confederate Veterans scrapbook, located in the Louisiana Room of the Shreve Memorial Library, Archives and Genealogy Department, Shreveport, Louisiana. It is not known who kept the record of the Caddo Guards.

### ROSTER - CADDO GUARDS

Company A, 25th Regt. LA Volunteers \_\_\_\_\_ in Shreveport, Louisiana by Captain W. Robson, Lt. Samuel C. Head, and Dr. G. W. Kendall. Left Shreveport on the Steamer Col. Terry. \_\_\_\_\_ 14th March, 1862. Arrived in New Orleans on the 18th March 1862 and mustered [quartered] in the Louisiana Cotton \_\_\_\_\_. There was an organization for a new Regt. S. Dier Brother,

We landed here in about four weeks from the time we started I am well and harty I am not satisfide here the country is very low and swampy the land is very rich and produces fine but I am afraid of my helth here I was up in White County on lettles red river and I like that country a great del better than I doe this there is some very fine cuntry about Sircy a little town on little red river about fifty miles below Batesville a man can get good land for one bit per acer there is a good many deer & bear in this country I have not killed any game since I have bin here but I have saw lots of them Bob killed one deer there has bin sever or eight bear killed in the nighbour hood since I have bin here We have had bar meat to eat evry day since we bin here tell brother gus that I saw a good many of our old acquaint-ecies in White County Nelson Black old man Walker the widow parks and John parks and Alexander Allen I stade all night with a man in wite county that said he was a kin to us he is a kin to the Pates there is a good many pates up in the next county above White they are sones and grandsones of old Claborn pate. I had no time to gow to see any of them when I was up thare Miss Barnes is very much dissatisfide with this country She started this morning her and Bob both back to Nashville She told me when she started that she was not a comming back anymore if she does not its likely I shall be up thare in the spring if I don't come in the spring I will be up thare in the fall give my bes respects to all inquiring fends tell Brother tom that I am a gowing to bring him a little young bear if I can get one this winter I spoke to old man hugings for one he is a old bear hunter he says if he catches any young ones this he will let have them & I will bring them with me when I come tell the old man I will bring him some bar meat when I come & some venesson I want you to be ready to gow with me to Cancies you & gus

Additional information furnished by Mr. TAYLOR, owner:

Benjamin and Elizabeth TONEY BICKHAM moved from GA to St. Tammany Parish, LA, and later lived near Covington, Washington Parish, where many of their children married and reared families. BICKHAM descendants can still be found in this area.

One of their sons, Francis BICKHAM, served at one time as a state legislator from Washington Parish. He married Rhoda ROBERTS and in 1837 moved to Caddo Parish where his plantation eventually encompassed more than 2000 acres. Bickham's Landing on Cross Lake was a regular stopping place for steamships on their way to and from Shreveport and New Orleans. Rhoda BICKHAM died in 1849 and Francis in 1850. Both are buried in the family cemetery on Cross Lake off the Blanchard-Furrrh Road.

Francis and Rhoda BICKHAM had 15 children, 10 of whom were still living at the time of their father's death. The older children and close relatives continued to live on the family plantation. The oldest living son, Benjamin Ramsey BICKHAM, became head of the family, with responsibility for the minor children as well as the minor children of his brother, George Roberts BICKHAM, and his wife's sister, Sarah Rebecca DANIELS. From all accounts, he did an outstanding job of caring for all of them, and several distinguished themselves and the BICKHAM name in the United States and Europe.

John Wood BICKHAM, the eighth child of Francis BICKHAM and Rhoda ROBERTS, was born in 1827, St. Tammany Parish, LA. He was named for his mother's stepfather, John WOOD of Maryland. John BICKHAM married Georgiana "Georgia" COLE in 1851 in Cass County, TX. She was a daughter of Ransom COLE, who had moved with some of his family, from Alabama to Caddo Parish and on to Cass County about 1850.

Ransom COLE stayed in Cass County after his wife's death, but moved to Brazos County sometime after 1860. His sons followed and became well-known business leaders in the town of Bryan. Ransom never married again and died in 1887. He is buried in the BICKHAM Cemetery.

John and Georgiana's first child was a daughter named Agatha Samantha, called "Sisy". The family probably lived in Panola County, TX, when she was born, although their stay there is not documented. They moved on to Robertson County, and by 1856 had settled in Brazos County, not far from Wheelock (in Robertson County). Their home became known as the "BICKHAM Place," and

later the "BICKHAM Community". John BICKHAM acquired a significant amount of property in the Cottonwood and Zack areas, near Tabor. He also had a cotton gin and a general store. His gin was one of two built about 1850. A third gin, built in 1860 was owned by Frank and Peter KIEFFER.

Peter was the father of Amanda KIEFFER BICKHAM, and was found murdered in 1872, by the Navasota River bridge. The identity of his murder was never discovered. The KIEFFER gin was burned to the ground in 1883 by Joseph ZABO because of family troubles. Joseph was also accused of horse stealing, and after finally being caught, a group of men hung him from an oak tree on the Robert HUDSPETH place. In 1900, Frank ZABO was ambushed and killed by Charley ELLISON of Wheelock.

John BICKHAM was known and respected for his knowledge of cotton production. His report on "Cotton in Brazos County" was included in the famous E.W. HILGARD report on cotton products included in the decennial census of 1880. His granddaughter, Grace SAMPLE WEAVER (now deceased), said, "During the Civil War, my grandparents and their family suffered great deprivation. The North blockaded out accessible seaports. They had to exist on whatever they could produce. I remember my Aunt Samantha telling of eating parched corn, which also substituted for coffee. My grandfather did not actively fight in the Civil War, but gathered food for the troops."

The southeast corner of the BICKHAM homeplace adjoined the northwest corner of the SAMPLE homestead. James Jasper SAMPLE had moved from Alabama to Robertson County TX in 1848 and married Susan Jane SUMMERVILLE. He died in 1878, leaving his widow with 9 children and a fairly large farm which she eventually divided among the children. Susan Jane married second, William Wiley RUDASIL, by whom she had 3 more children. One son by her first marriage, Thomas Henry SAMPLE, married the youngest BICKHAM daughter, Georgia Rosalia "Rosa".

After Georgiana BICKHAM's death in 1882, John married Mrs. Lula E. CASTLE (her first husband, Henry A. CASTLE, another neighbor to the BICKHAMS in LA, was born in New York and died in 1880 from lung problems developed while living in LA). Lula is buried in the BICKHAM Cemetery in a plot with the MCGEEs and CASTLEs. John BICKHAM died in 1888 and is buried next to his first wife, Georgiana.

In addition to owning the Bible, Roy TAYLOR also has many letters, mostly dated from 1882-1945, which were written by virtually all of the family members named in the Bible. These letters have been used to identify the handwriting of the individual entries in the Bible.. This Bible record has not been published or widely shared. Some headstones in the BICKHAM Cemetery in Blanchard, LA, are in conflict; however, at least one of the headstone dates appears to have been changed in very recent times. A few stones are not very old and are not contemporary with the correct time period of dates. The Bible dates may be the most reliable source, so perhaps some of the conflicts may be cleared up. The Francis BICKHAM Bible, which would contain many other important dates, is said to be in the possession of a descendant of Georgia Rosalia BICKHAM SAMPLE

#### TIPS WORTH PASSING ON

The Illinois State Historical Library has a collection of about 4,700 IL newspapers on 67,000 reels of microfilm & they are available on interlibrary loan. Inquiries should be address to: Sandra Stark, Illinois State Historical Library, Old State Capitol, Springfield, Illinois 62701.

Did you have an American ancestor who went to sea in the 1800's? If so, he may have applied for the "Seaman's Protection Certificate", which was designed to stop the British from impressing Americans into the British Navy on the high seas. These certificates were issued from 1796 to 1897 and were especially popular from 1796 to 1820. For info, write the Archives Division, National Archives, Washington D.C. 20408.

Cost of copies from the National Archives has increased. Census records are now \$6, and military, passenger arrival & Indian records now being \$10. Use the new forms for these records.

If you have native American ancestors, another source you might want to use is the Native American Heritage Center, Joann Jones, Caretaker of the Genealogical, Historical & Cultural Heritage, Orem, Utah 84059-0064.

An informative booklet entitled "Alabama Genealogical Societies" can be obtained from the Natchez Trace Gen Soc, PO Box 420, Florence AL 35631-0420. It lists over 30 genealogical groups in AL & other information.

The Polish Genealogical Society, 984 N. Milwaukee Avenue, Chicago IL 60622, has an ancestor index card file in it's library available to all researchers. Send a SASE for guidelines to submit or extract names.

The office of the Grand Secretary maintains all the Masonic Lodge records of Illinois of it's members. Records contain name, birth date & place, occupation at time of petition, and dates degrees conferred. Records since 1840 are available. Write Office of Grand Secretary, Box 4147, Springfield, IL 62786.

The 1820-1830 Wisconsin federal censuses are with those of Michigan; the Nevada census is included with Utah, the 1860 Wyoming census is with Nebraska, and the 1860 Colorado census is with Kansas.

Check Louisiana records for some born in Missouri between 1805 and 1812. During these years, Missouri was part of the Louisiana Territory.

UNMARKED BURIAL LEGISLATION ENACTED 1991  
State of Louisiana

Member, Evelyn HALL, has shared an article written in the publication "Parks Dispatch" by Nancy HAWKINS, Division of Archaeology.

The following are excerpts from 1991 legislation creating the Unmarked Human Burial Sites Preservation Act. The Act becomes effective on 1 Jan 1992.

The legislature finds that existing state laws do not provide for the adequate protection of unmarked burial sites and of human skeletal remains and burial artifacts in such sites. As a result, there is a real and growing threat to the safety and sancity of unmarked burial sites, both from economic development of the land and from persons engaged for personal or financial gain in the mining of prehistoric and historic Indian, pioneer, Civil War, and other soldiers' burial sites.

It is unlawful for any person, entity, or group, to whom the (Unmarked Burial Sites) Board has not issued a permit to knowingly:

1. Disturb an unmarked burial site or any human skeletal remains or burial artifacts in an unmarked burial site.

2. Buy, sell, barter, exchange, give, receive, possess, display, discard, or destroy human skeletal remains from an unmarked burial site or burial artifacts....

3. Allow any person, entity, or group access to an unmarked burial site, human skeletal remains, or burial artifacts for the purpose of disturbing them.

4. Provide funds to or for any person, entity, or group for the purpose of disturbing any burial site, human skeletal remains, or burial artifacts.

Any person who has reason to believe that he or she has discovered an unmarked burial site or received human skeletal remains from an unmarked burial site shall notify the law enforcement agency of the jurisdiction where the site or remains are located within 24 hours of discovery. Any person who has reason to believe he or she has discovered or received burial artifacts shall notify the board through the Division of Archaeology within 72 hours of the discovery.

The board shall make reasonable efforts to identify and locate persons who can establish direct kinship with or descent from the individual whose remains have been found....If the unmarked burial site or the human skeletal remains can be shown to have ethnic affinity with a living Native American tribe, the board shall notify the tribe of the discovery... (and) the tribe shall have control of the disposition of the human skeletal remains....If no direct relation or descent is found or if no ethnic affinity....can be shown...., then the board shall determine the proper disposition of the human remains.

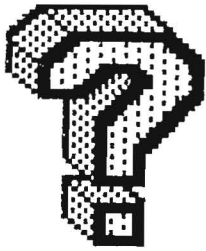

MEMOIRS OF THE 19th INFANTRY  
BY  
ISALIAH EDWARD BAZER OF COMPANY F

The first battle I was in under this "Old Flag" was fought at Shiloh in April of 1863. Then a part of our company started to Vicksburg to reinforce that company, but we never got there: we stopped at "Big Black River" 12 miles from Vicksburg, having gotten word that the confeds had been busted. We then fell back to Jackson. We here fortified with the other Regiment and fought back.

The next stop for us was Chattanooga, in the fall of 1863. At Chickamauga on our way we had two days battle, whipped them good. Later we fought them on Look-Out-Mountain. (My First Prayers) The next day on Missionary Ridge. From there we retreated to Dalton, Georgia, and went into winter quarters.

In the spring of '64 we retreated from Dalton to Atlanta which we fought every step of the way for a month. The first battle I was in under this Flag was at New Hope Church near Atlanta, then further on at Resaca, Georgia, was another hard battle. After arriving at Atlanta we had a long siege of skirmishes, but had a hard battle in July which was lost. We left here and went to Jonesborough where we were engaged in another battle. From there we made our way to Nashville, Tennessee. At Florence, Alabama, on our way we had a skirmish, then at Franklin, we fought as hard a battle as was fought during the war. This is where General Claibourne was killed on the Breast Works. We run the Yankees on into Nashville, where they had Headquarters, as we were hindered by a big snow, we halted awhile.

When the snow melted the Yankees came out of the camp after us, so we had to fall back into Mobile, Alabama. About the first of April, '65, we made it over to Blakely, near Mobile. Here we had a long siege of fighting, about 30 days, at last we had to give up this place and retreated to Meridian, Mississippi where we stacked arms and surrendered.

After "Old Flag" was lowered and the white flag was raised, Mr Flournoy snatched the flag and stuffed it in his bosom and that is why we have it here now. Here I was on picket duty, and was captured and carried to Ships Island in the Gulf of Mexico, near New Orleans, where I stayed about 30 days, and was brought back to Vicksburg, and was paroled with 3 days rations. I walked back to Jackson, Mississippi, then went to the home of my uncle at Dearsonville, Mississippi where I stayed about a month with the measles. After this I made my way home in DeSoto Parish, Louisiana. Arriving about July first, 1865, having left January 6, 1863 at the age of 18 years and six days. Shreveport Times 1921

#### AS A DEFENDER SAW THE SIEGE AT VICKSBURG

The following excerpt was from the regimental history of the Third Regiment, Louisiana Infantry, by W. H. Tunnard, published in 1866. Taken from the book Struggle for Vicksburg published 1982.

July 4. Early in the day it became known that negotiations were pending for the surrender of the Southern stronghold.... When the Federals first appeared.... no word of exultation was uttered to irritate the feelings of the prisoners. Every sentinel who came upon post brought haversacks filled with provisions, which he would give to some famished Southerner, with the remark, "Here Reb, I know you are starved nearly to death."

HEBREW REST NUMBER TWO  
Shreveport, Louisiana

Data researched and recorded by Eric J. Brock 1991

The cemetery known to most Shreveporters as "Hebrew Rest" is actually the second of three cemeteries to bear that name. The first, originally known as Hebrew Rest Number One, was opened in 1858 adjacent to Oakland Cemetery, the first non-sectarian municipal cemetery in the city of Shreveport, Louisiana. With the rapid growth of the Shreveport Jewish community in the years following the Civil War it was evident that a much larger cemetery would soon be needed. By the year 1885 Hebrew Rest at Oakland was nearly filled and the Jews of the City decided to purchase a larger burial ground which would serve the needs of the community for years to come. A two acre lot was owned by one of the members of the city's Reform Congregation was chosen. The site was within the city limits but in an area just beginning to be developed. Benjamin Jacobs, a Prussian-born merchant who had come to Louisiana with his brother, Edward, in the 1840s was the owner of the property and sold it to Congregation B'nai Zion (name interchangeable with Hebrew Zion until the name B'nai Zion was formally adopted in 1915) for \$600.00 well below the market value of so large a tract of land fronting a major thoroughfare. When Benjamin Jacobs died a year later he was buried in the non-sectarian section of the old Oakland Cemetery since his wife was a Baptist and they opted to be buried together in a family plot; the same was true of Edward Jacobs, who married his brother's wife's sister-- both brothers' family plots are located remarkably close to the fence separating Hebrew Rest Cemetery Number One from the rest of Oakland Cemetery.

The sale of the two acres at 1473 Texas Avenue was finalized on August 24, 1885 and the original instrument of conveyance may be seen today in the Office of the Clerk of Court of Caddo Parish, conveyance number 28251. Upon purchase of the property it became known as "Hebrew Rest Cemetery Number Two," old Hebrew Rest taking on the suffix "Number One." Within a few years, however, Hebrew Rest Number One had fallen into nearly complete disuse and after 1928 no printed references to Hebrew Rest Number Two call it anything other than simply "Hebrew Rest Cemetery." That is what it is commonly called today, few are even aware that two other cemeteries also bear the same name ( the third is Hebrew Rest Number Three, adjacent to Greenwood Cemetery on Stoner Avenue. It opened in 1934 and is used by Temple B'nai Zion's congregation to this

day--most refer to it, however, as "the Jewish section of Greenwood Cemetery").

Nearly a year passed after the purchase of the cemetery land before it actually began to fulfill its intended purpose. A portion of that time was spent negotiating right of ways with the railroads whose tracks bordered the cemetery on the south and west sides. It is difficult to imagine today but what is now Hebrew Rest Cemetery (no.2) was entirely covered by a thick growth of vegetation, all of which was removed. Over the course of the intervening year the cemeteries were laid out, walkways and driveways paved, fences erected and a toolhouse built for the groundskeeper. Lots went on sale in mid 1886 beginning at \$100.00 each for family plots and running to \$200.00. Single grave spaces in "Membership Row" began at \$25.00 for adults; history does not record the original cost of lots in "Children's Row," an unfortunate necessity in the Victorian era with its high rate of infant mortality. Gravespaces in "Pay Row" ran the same as in "Membership Row" but were not limited to congregational members--the only criterion for burial in this cemetery was being Jewish. Occasionally lots in "Pay Row" were given free of charge to indigent Jews. When space for such charity burials began to run out and when space for children's burials began to run out, these interments were made in-between the lots originally set aside for "Membership Row," "Pay Row," and "Children's Row," thus blurring the distinction between them. Today (1991) it is difficult to tell that these sections are absolutely filled since only a moderate percentage of the interments bear markers (mostly early "Membership Row" burials); all of the burials are, however, recorded in the Cemetery Book of B'nai Zion Temple which begins with the 1886 opening of the cemetery. With the singular exception of the lots making up the three "Rows" mentioned above, Hebrew Rest Number Two is laid out in individual, separated family plots. This is a departure from the traditional European-style Jewish Cemeteries, of which Hebrew Rest No. 1 was one, in which everyone was buried in order of expiration rather than the family units. Like many other cemeteries, Hebrew Rest No.2 follows the popular cemetery layout of its day, whether Jewish, Gentile or non-sectarian.

The first burial in Hebrew Rest (No. 2) took place on August 11, 1886 when Marx Baer was laid to rest. Baer was one of the founders of B'nai Zion Congregation as well as its predecessor, Congregation Har El, of which he had once been President. Baer was a cotton planter and a Confederate veteran, his son-in-law, Ben Holzman (who is also buried in this cemetery) was Shreveport's second Jewish mayor and, when he died, was the last survivor of the crew of the Confederate ironclad gunboat "Merrimack". Baer's great grand-



daughter (and Holzman's granddaughter) is Kitty Carlisle, widow of composer Moss Hart.

Site Description:

Hebrew Rest (No. 2) occupies an irregularly shaped tract of land originally measuring two acres but now only slightly less. The present boundaries are Texas Avenue on the north, Southern Pacific Railroad on the south, Depot Street on the east, and Interstate 49 on the west. The original Boundaries were almost exactly the same except on the west, the upper part of which was bounded by the tracks of the Texas and Pacific Railroad and the lower part of which was bounded by the pie-shaped tract of land owned by A. Newman. The tracks now owned by Southern-Pacific were then the property of the now Defunct Shreveport, Texas, & Pacific Railroad. In the mid-1980s when work began on I-49, a few square feet in the southwest and northwest corner were lost to the freeway project; there were no burials in these parts of the cemetery (tool shed and service gate were, however, lost).

The whole of the cemetery is enclosed by fencing. The original iron fence survives only on the Texas Avenue side with a small portion remaining on the I-49 side at the end nearest Texas Avenue. The remainder of the Cemetery Boundary is fenced with chain link. Fortunately, the chain link fencing is largely obscured by vegetation. Large Trees front the cemetery on its Texas Avenue side but there are no trees at all within the cemetery with the exception of a large oak near the northwest corner and a few large crepe myrtles near the rear of the cemetery. Trees do, however grow along the fences on all sides creating the illusion that there is more foliage here than there is. The original fence along Texas Avenue is of heavy cast iron manufactured by the Champion Iron Fence Company of Kenton, Ohio. The original gates facing Texas Avenue remain, though minus their lichgate arch which once proclaimed the name of the cemetery to passersby. A pedestrian gate also remains along Texas Avenue, as do two of the original heavy iron corner post, though much deteriorated with age. There are no fences around private lots within the cemetery, though many of the lots are enclosed by curbs of limestone, granite, or more often, concrete. Every family lot is separated from the others by a walkway. All told, twenty five walkways and two driveways criss-cross the cemetery separating the lots from each other. The driveways were designed specifically for horse-drawn hearse and will not accommodate modern vehicles.

The only lots not separated are those originally set aside as "Children's Row" (lots 1,2,& 105,"Membership Row"(lots 3-12) and "Pay Row(lots 13,36,37,60,61, and 84). While several of the "Pay

Row" lots are still identifiable as such, the number of burials made within and in-between these lots in dense and close proximity to one another has made it impossible to refer to then anything other than the "Undefined Section" (U in the list that follows). Every one of the family lots contain burials though not all bear markers ( the only exception are lots 132-135 which were never sold and contain no burials). The vast majority of interments at Hebrew Rest (No2) bear markers, those without are a distinct exception, still it should be noted that the exception exists, especially among those in the "Undefined Section." Some suicides (though not all) are also unmarked, though suicides are buried in their family lots as opposed to the edge of the cemetery, this being a Reform cemetery and not following that particular tradition.

Altogether, the cemetery is kept in exceptionally good condition. It is seldom used for burials anymore, though burials are made here on occasion even yet. It is certainly one of the best maintained cemeteries in the city of Shreveport, despite the obstacles presented by its layout, which is not friendly to modern mechanized moving equipment.

#### BURIALS AT HEBREW REST CEMETERY NUMBER TWO:

note: the number at the end of each line refers to the lot number in which that person is buried, a U indicates that they are buried in the undefined section of the cemetery, either along the south or east edges. No effort has been made to transcribe the stones themselves, some of which are rich in Hebrew and many of which also give birthplace and place of death. This information may be found recorded in the Cemetery Book of Temple B'nai Zion along with other information not found on the stones (cause of death, occupation, etc.) Some additional information is occasionally given in parentheses, typically references to military service; CSA refers to Confederate States of America, indicating that person fought in the Confederate Army during the Civil War, USA indicates that the fought in the Union Forces( there is only one Union veteran buried in this cemetery). Few markers cut after World War I give any information other than English name and vital dates, however, unfortunately, these plainer marker have become the norm in most modern cemeteries and comprise the decided majority in this cemetery as well.

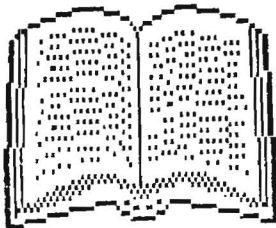

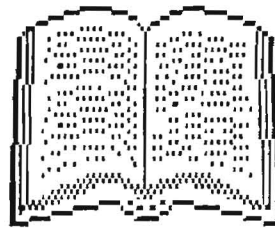

FRIENDS OF GENEALOGY, INC.  
PROPOSED AMENDMENTS TO THE BYLAWS

ARTICLE I - NAME

The name of this Organization shall be Friends of Genealogy Inc. The founding date is May 7, 1988.

ARTICLE II - PURPOSE AND OBJECTIVE

The purpose of this Society is to foster an interest in and to promote and encourage the development of genealogy.

The objectives of the Society are: 1.) To share and assist any individual or organization with a common interest in genealogy. 2.) To promote and encourage the preservation of genealogical and historical materials. 3.) To teach the principles of correct documentation.

ARTICLE III - MEMBERSHIP

The membership of this Society shall be open to all individuals and organizations interested in accepting our purpose and objectives. There shall be the following classifications: 1.) Individual 2.) Family 3.) Publication 4.) Sustaining-Patron 5.) Life

Annual dues shall be determined by the Board of Directors and approved by 2/3 vote of the membership at a regular meeting. (Add: Life-time membership fee shall be determined by the Board of Directors with 2/3 vote of approval by the membership.)

The fiscal year shall be from January 1 through December 31. Dues shall be due and payable by January 1. Dues not received by March 1 shall be considered delinquent.

All members in good standing shall be eligible to vote on all business of the Society. There shall be no proxy or voting by mail. A member in good standing is one with dues current and who supports our purpose and objectives.

ARTICLE IV - OFFICERS

The officers of this Society shall consist of the President, 1st Vice President, 2nd Vice President, Secretary, Treasurer, Historian and Publication Editor (Add: And Immediate Past President.) Any additional officers deemed necessary by the membership may be elected by a majority of the membership.

There shall be four trustees, two elected in odd year and two in even year.

Officers and Trustees shall be elected for two years. They may not be elected for more than two consecutive terms. (Add: With the exception of the Editor who may serve at the discretion of the Board of Directors with 2/3 vote of approval by the membership.)

The President shall take no action without the approval of the Board of Directors.

The President shall appoint all committees with the approval of the Board of Directors.

The President shall be an ex-officio member of all committees except the nominating committee.

The Vice Presidents shall, in their order, in the absence of the President, assume the responsibilities of the office of the

President and exercise all the powers of that office.

The 1st Vice President shall assume the duties of Program Chairman and shall conduct any business requested by the Board of Directors.

The 2nd Vice President shall be the Membership Chairman and shall perform all other duties requested by the Board of Directors. (Add: This office shall be in charge of all publicity.)

The Secretary shall record all minutes of both the Board of Directors and regular meetings and furnish the President with a copy. The office shall be custodian of all records of the Society and conduct general correspondence and maintain a list of all members and committees.

The Treasurer shall be custodian of all funds and deposit such in a bank approved by the Board of Directors and keep all receipts and pay all bills on order of the Board of Directors. (Add: All monies must be disbursed through the Treasurer.) All checks shall be signed by either the Secretary, Treasurer, President (Add: Or the Past President); any two (2) of the three (3) officers. The Treasurer shall submit a monthly financial report to the Board of Directors and the membership. The financial books shall be closed by the Treasurer thirty (30) days before the annual meeting and submit all financial records to the Auditing Committee. The report of the Auditing Committee shall be made at the annual meeting. The Treasurer shall send out notices to members advising them of delinquency of dues.

The Historian shall maintain the Society's History Book. This office shall keep a file of all family records of the membership. A copy of all publicity notices or articles shall be kept by the Historian.

The Publication Editor shall be chairman of the Publication Committee and shall have general supervision in procuring, compiling, publishing and the general distributing of the Society's official publication. (Add: Publication Committee may include Associate Editors and Contributing Editors. The Publication Editor is the only member of the committee with a voting right on the Board of Directors.)

#### ARTICLE V - PUBLICATIONS

There is hereby established an official publication for the Friends of Genealogy, Inc. Distribution date shall be determined by the Society membership. The compiling, publishing and distribution of the official publication shall be directed by the Publication Committee and approved by the Board of Directors. The official publication shall be sent to all members of the Society and exchanged with other genealogical organizations on an exchange basis. These exchange publications or any other publications shall be given to Shreve Memorial Library within forty-five (45) days. Duplications will be placed in society's Lending Library. (Change to read: It shall be determined by the Board of Directors with approval of 2/3 membership where to place any duplicate materials.)

#### ARTICLE VI - NOMINATIONS AND ELECTIONS

The Nominating Committee shall consist of five (5) members -

two (2) shall be appointed by the Board of Directors and three (3) elected from the membership at least 90 days prior to the annual meeting.

A chairman shall be selected on the day of the appointment of said committee. The committee shall meet on the call of the chairman or majority of the committee. The committee shall consider the qualifications of all candidates and submit one name for each office to be filled as the first order of business in the November meeting. Nominations may be made from the floor provided the candidates meet the qualifications of the office and have consented to serve if elected.

The election shall be by ballot. If there is but one nominee the vote may be by voice. A majority vote shall be required for election to office. A tellers committee of three (3) persons shall be appointed prior to the election to serve as official counters. Elected officers shall be installed at the annual meeting and assume the duties of said office January 1 of the following year. The retiring officers shall submit to their successors all records of the office on or prior to December 31.

#### ARTICLE VIII - BOARD OF DIRECTORS

The Board of Directors shall be comprised of the elected officers, four (4) trustees and the Immediate Past President as long as they are members in good standing in the Society.

The Board of Directors shall meet prior to regular meetings and be responsible for necessary business between regular meeting of the Society. They shall submit a complete report to the membership of any and all actions.

At the beginning of each administration, an inventory of all Society property shall be taken and a copy shall be kept in the official records.

The Board of Directors shall select the bank to be used by the Society.

The Board of Directors shall fill all vacancies in all elected offices except in the office of President.

The Board of Directors shall perform other duties as the membership shall request.

#### ARTICLE IX - COMMITTEES AND DUTIES

The President shall appoint, with the approval of the Board of Directors, the following Committees: 1.) Finance & Budget 2.) Auditing 3.) Workshop/Book Fair 4.) Telephone 5.) Hospitality 6.) Resale 7.) Publication Exchange 8.) Other committees necessary for the success of the Society.

The Finance and Budget Committee shall consist of Treasurer, one member from the Board of Directors, and three (3) persons from the membership. They shall prepare an annual budget of the estimated receipts and disbursements from membership dues and other sources. The budget shall be presented to the Board of Directors at the January board meeting and presented to the membership at the regular February meeting.

The Auditing Committee shall consist of one Board member and two (2) members at large and shall examine the Treasurer's books and shall submit a report and/or recommendations at the annual meeting.



The Workshop/Book Fair Committee shall consist of four or as many members as are needed to plan workshops and/or book fairs under the direction of the Board of Directors.

The Telephone Committee shall attempt to call all local members prior to each meeting giving pertinent information.

The Hospitality Committee shall be responsible for greeting members and guests and procuring refreshments for all meetings. The committee shall provide any name tags.

The Resale Committee shall be responsible for the ordering and selling of resale items, with approval of the Board of Directors. Resale chairman shall keep a complete record of all sales and purchases.

The Publication Exchange Committee shall solicit, receive, catalog, and deliver to Shreve Memorial Library all exchange publications.

All committees shall perform any other duties as directed by the Board of Directors.

#### ARTICLE X - QUORUMS

A quorum for the Board of Directors for transaction of business shall be seven (7) members. In extreme emergency, the President may poll a quorum of Board members by telephone. Any action therefrom shall be justified at the next Board meeting.

A quorum for regular meetings shall be thirteen (13) members in good standing and eighteen (18) members in good standing for the annual meeting.

A quorum for all committees shall consist of a majority of its members.

#### ARTICLE XI - PARLIAMENTARY AUTHORITY

Roberts Rules of Order shall govern this Society in all cases not provided for in these By-Laws.

#### ARTICLE XII - AMENDMENTS

These By-Laws may be amended by a written resolution signed by three (3) or more members in good standing and presented to the Board of Directors. The Board of Directors shall present it to the membership, with their recommendation. Notice of the nature of the proposal shall be given to the membership prior to the meeting.
