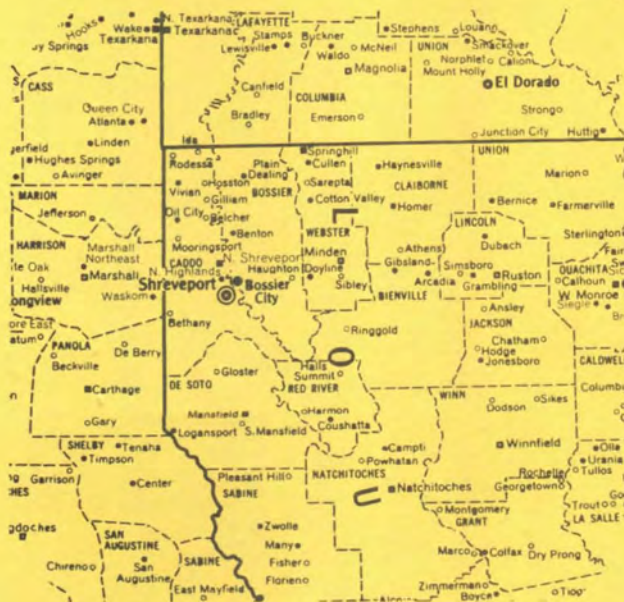

Additional Notes from Mrs. Annie Garland Parker.

The preceding pages are copies of the Methodist Work in the Hemphill Community. This Community is about ten miles from the present town of Boyce, La.

The Church Building - at that time- was facing the old road that passed the Hemphill Star Cemetery, on the right hand side, on a hill over-looking the road, which led on to Clifton Crossing.

The Pastor of the church, Jim Owens, lived about one mile from the Church Building on the left hand side of the road. Mr. Owens and his wife, did not have any children of their own, but partly raised some of the orphan children of the Owens family. They raised a girl named Willie Ann Coleman, who married Weyman Cudd.

Mr. Owens is buried in the Hamphill Star Cemetery. The grave is marked with a very nice monument -

MIJAMIN J. OWENS  
Born July 26, 1831  
Died Dec. 23 1903

He was a Methodist Preacher and an uncle of Edmond Owens. We do not have any record of any other members of his family being buried there.

Lydia Cutts was a Parker, sister of Isiah Parker and daughter of Benjamin Parker, who was born in Mississippi.

Julia Smith was a Garland, and Monterey was her daughter. Her husband was David Smith, who died in 1884 and is buried along with two daughters in the center of the Cemetery. Julia and all other members of this Smith Family are buried at the Presbyterian Church in the edge of the mountains, near Calico Rock, Arkansas.

JAMES WILLIAM COLEMAN  
1813 -- 1882

This has proved out to be the first grave to be put in the Hamphill Star Cemetery. For many years there was a picket fence around this grave, and many tales were told as to who it was -Thank God for this marking.

The following is a record that was found among the effects of a deceased Aunt. It was evidently included in a letter, but there is no date or signature. The stationary has a monogram in the upper left corner formed in a circle. "Windsor Castle." The neice thinks that this is the name of an English Ship.

Richard Sturch was born in Shutford Parish, Oxfordshire, England on the 10th day of April 1791. He died on the 13th day of October 1872.

Elizabeth F. Sturch was born in York District, S. C. on the 8th day of July 1807. Died on the 20th day of January 1874.

George Washington Sturch was born in DeKalb County, Ga. 10th of June 1828. Died on the 5th day of December 1878.

Andrew Jackson Sturch was born in Habersham County Georgia on the 4th day of Jan 1830. Died at Vanburen, Ark. on the 18th day of Jan 1863.

Your Father - Elic Jefferson Sturch was born in Madison Co. Ala on the 25th day of March 1832. Died at Pinebluff, Ark. in March 1863. Do not know the day of the month on which your father died.

Sally Ann Sturch was born in Madison Co. Ala. on the 23rd day of Aug 1834.  
Amanda Caroline Sturch was b in Madison Co. Ala. the 12th day of Dec 1836.  
William Wesley Sturch b in Hardiman Co. Tenn. the 1st day of March 1839.  
Betsey Jane Sturch was b in Franklin Co. Ala. the 1st day of Dec 1841.  
Mary Frances Sturch was born in Franklin Co. Ala. 29th day of April 1844.  
She died in Independence Co. Ark. on the 26th day of July 1890.  
Richard Columbus Sturch was born in Tishamingo Co. Miss. the 23rd Oct 1846.  
Silas Houston Sturch was b in Franklin Co. Ala the 28th day of March 1850.  
James Riley Sturch was b in Independence Co. Ark. the 29th March 1854.

C. between 1822 and 1830. They had 8 children born in S. C. : Margaret b 1830; Hannah b 1831; Mary A. b 1833; Robert b 1835; Solomon b 1837; Sarah L. b 1839; Nancy E. b 1830 and Emily N b 1844. They migrated to Choctaw Co. Miss 1847/1848. (The son of 2nd William, Henderson Somerville, b 1846 S. C. m Francis Caroline -----? b 1850 Miss. They moved to Carroll Co. Miss where their son James Henderson Somerville b 23 Feb 1865 m. 13 Aug 1899 to Geneva Marie Duthu b 7 Apr 1881 Miss. Dau of Joseph L. Duthu ? ). Any help appreciated. Mrs. Mattie R. SAUNDERS, WALKER, IRVINE, BOWEN, WILSON - James Saunders b 1769 m in Georgia and had three children: Augustus B. b 1791; m Hannah Walker of Tenn and moved to Lawrence Co. Miss in early 1820's. Winifred b 1793 m Jesse Lankford & moved to Calhoun Co. Arkansas. Nancy m Richard Irvine and moved to Lawrence Co. Mississippi.

James married second time in Tennessee to Levisa Bowen and had four children: Samuel A. b 1813 m Ann ? and lived in Dallas Co. Arkansas. John H. m Martha Dillard and died in Pierce City, Missouri; Will Bowen Saunders, no history, Tibitha Mary b 1816 m 1st John Perdue; 2nd B. W. Harris and is buried with her mother in Wilson Co. Tennessee.

James had a brother LEWIS SAUNDERS, that m Martha Saunders, they lived in Lawrence Co. Mississippi in the early 1820's.

The Powells moved from north Mississippi prior to the Civil War to near Hope, Arkansas. Charles Peters Powell b 1885 m Marie Wilson b 1887 of Prescott, Arkansas.

## COTILE-BOYCE POST OFFICE

From notes submitted by: Annie G. Parker

Many letters were written through the years, and just about every kind of a report given on the Cotile Post Office. At first I could not get any names of the Postmasters. One prominent Historian had made a bad mistake, so this kept me writing when I saw any change. This came on February 7, 1969: "A further examination of the records of the Post Office Department in the National Archives shows that a post office was established at Cotile, Rapides Parish, Louisiana, on January 6, 1819. The names of the postmasters who served at this office until 1824 and their dates of appointment are:

James Fort Muse ----- January 6, 1819  
Heritage Howerton ----- April 16, 1822  
Daniel Robert ----- October 13, 1824

We regret any inconvenience that the error in our letter of January 22 may have caused you. The registers of postmaster appointments among our holdings show that a post office was established (date not given) at Cotile, (parish not given) Louisiana with FRANCIS HENDERSON appointed (date not given) as its first postmaster. These registers do not show the date of discontinuance of this office or any relevant dates other than October 1, 1817, which was the date of Postmaster Henderson's first return to the Postmaster General."

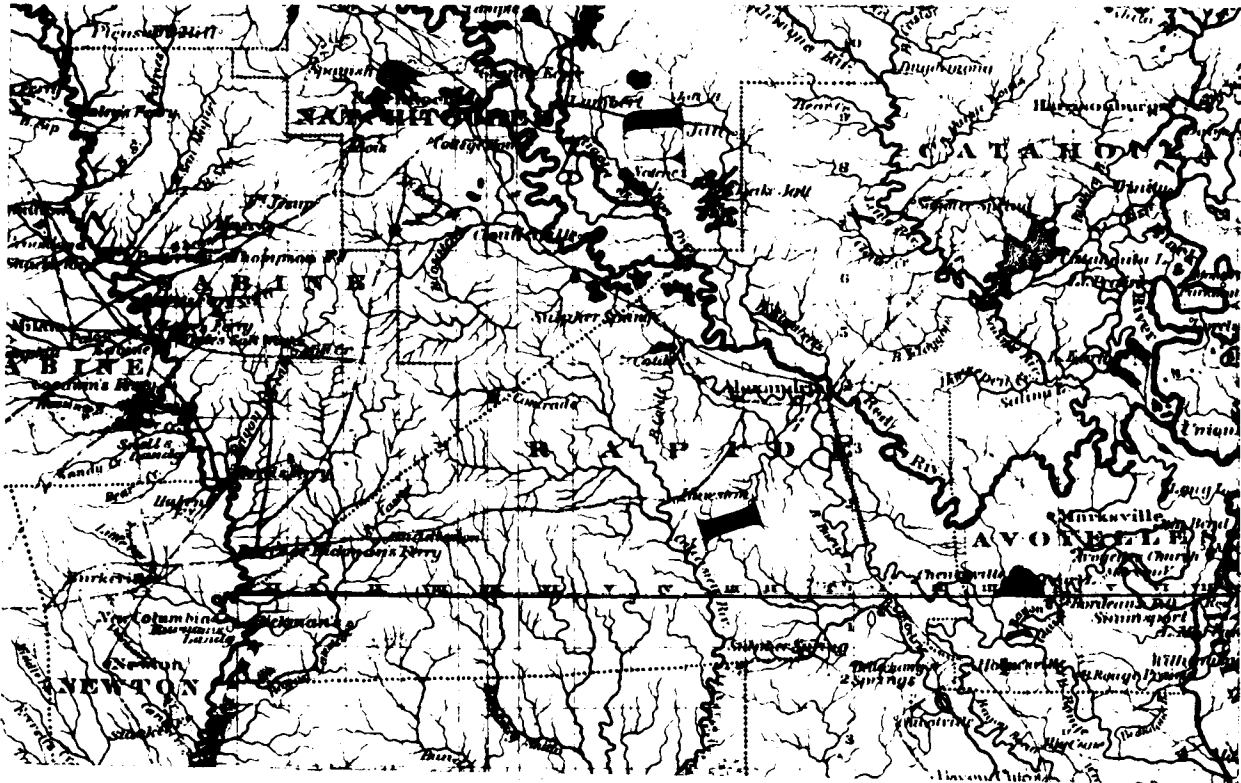

Records show the site changed May 18, 1883. William H. Simon was postmaster when the site was changed to Cotile Landing, but it seems the way the records read that the name was changed before the move. The Old Settlers did not accept the name of Railroad Station at Boyce until 1885 (Legal Proof). The traditional story from the Simon family says Mr. Simon was first postmaster of the Boyce Post Office. Do know that the settlers at that time from Cotile to Cotile Landing raised cain about the changing of the name. In the 1880 Census the residents of what became Boyce were listed as living in Cotile Village.

The map below is from an 1847 Map of Louisiana. The Map shows Stage Lines and Public Road with double line around Rapides Parish and Cotile Bayous, from Alexandria to Cotile Landing. Note first Railroad from Alexandria to Cheneyville.

Rev. John McCaully, died 19 Apr 1857, in Madison Co., Miss. He was born 6th Feb 1779, in Tyrone County Ireland. He was married 14 May 1803 and left Ireland on 14 May 1804, landing in Baltimore, Md. on 14 August 1804. A Methodist minister for 58 years, in Ireland, the states of Pennsylvania, Maryland, Kentucky, Tennessee, and in Mississippi, moving to this state in 1834. "A large family" mentioned, but no names given in biography.

Rev. Lewis Garrett was born 24 Apr 1772 in Pennsylvania and died 28 Apr 1857 near Vienna, Miss. Soon after his birth, his father, Mr. Lewis Farrett, removed to Virginia but sold his possessions there in 1779 and with his wife and eight children set out for Kentucky, dying enroute at a station on the Clinch River. His mother and the children, under protection of her brother, Morris Given, continued the journey and settled at Scott's Station, between Dicks and the Kentucky Rivers in the fall of 1779.

In the spring of 1880, a brother, Phineas Garrett, age 11, was captured by the Indians and never heard of again. In 1783, another brother, Eli, age 16, was also captured by Indians but was recovered eighteen months later. In 1848, Rev. Lewis Garrett published his recollections of the experiences of his family and other early settlers of this area of Kentucky. Rev. Garrett survived by his wife, two sons, and several grandchildren (none named), three sons had preceeded him in death.

Kinsman Divine, Esq., was born 1790 in Connecticut. In 1797, his father moved to Albany Co., N. Y., from whence brother Divine immigrated to Miss.,



settling first in Claiborne Co., then in Jefferson. On 22 May 1814, he married Miss Elizabeth D. Saunders, joined the M. E. Church in Sept. 1821, and left his wife, a large family of children and grandchildren to mourn him.

PLEASE NOTE: These biographical sketches are usually very long, naming many Methodist ministers and prominent persons, but seldom any member of the family.

## NEUTRAL STRIP

Condensed from HISTORY OF SABINE PARISH

by John G. Belisle, published 1912.

Spain had been much displeased because of the sale of Louisiana to the United States. The western frontier of Louisiana was the scene of Spanish hostility to the United States. The boundary between French Louisiana and Spain's Mexican empire had never been definitely fixed, and at the time of Jefferson's great purchase Spain claimed all of Texas as well as a strip of land in Louisiana lying between the Sabine River and the Arroyo Hondo, a tributary of Red River, seven miles west of Natchitoches, extending north along Red River and south, on an imaginary line to the Gulf.

No agreement was reached as to the western boundary until 1820 when the United States acquired the Florida Territory, and by the same treaty relinquished to Spain all claim to Texas, the Sabine River was designated as the boundary. In 1806 General Wilkinson and the Spanish General agreed this should be a neutral territory. For fourteen years this section had no government of any kind, thus it became the rendezvous for outlaws from the United States, Mexico and other parts of the world. It was the home of robbers, murders and plotters against the government. The whole of SABINE PARISH was included in this "NO MAN'S LAND". Natchitoches became the chief army post on the frontier.

Pending the settlement of the Neutral Strip the army remained at Natchitoches, and in 1812 Augustus Magee, a young lieutenant, who was stationed there, resigned his position in the army and began to organize a regiment for the invasion of Texas in the aid of Mexico in her fight to end Spanish rule. They were successful in two or three battles, but suffered a disastrous defeat at the battle of Medina.

A few years later a Dr. James Long, with a Mexican commander named Gutierras, led two expeditions against the Spainards, but ended in defeat and the death of the brave doctor. Many plots were hatched in the Neutral Strip. It was here that Aaron Burr, once vice president of the United States, expected to get recruits for the conquest of Mexico and Louisiana; and to establish a Western empire over which he should preside, but ended in his indictment on a charge of treason and his complete disgrace.

There were two great avenues of travel through Sabine Parish, the road from Natchitoches to San Antonio, opened by St. Denys, passing through Fort Jesup and the present town of Many, and the highway known as Nolan's Trace, blazed by Phillip Nolan, which extended between Alexandria and Texas. Fallen Springs, four miles south of Many was a popular camping ground, and in this vicinity many robberies and murders are said to have taken place. There were stories about buried treasures of silver and gold the robbers are supposed to have buried along these roads, but if any man had recovered any of these treasures, he has kept it to himself.

Many of these characters left good homes to seek their fortunes in the wilds, while others were fugitives from justice, but their names are forgotten, and their deeds remembered only in connection with the stories of the pioneers.

Several years before the boundary between Louisiana and the Spanish province of Texas was settled, immigrants from the old states had settled in West Louisiana and located in the Neutral Strip within the present boundary of Sabine Parish. In 1803 a regiment of United States troops

in command of Col Cushing was sent up Red River to repel Spanish aggression. English speaking homeseekers followed the soldiers, coming from all parts of the United States. They represented various races of Northern Europe, the German, the Irish, the Scotch, the Dutch and the Anglo Saxon. They sought the unoccupied lands where they could build their homes. Many brought their families and some brought slaves but most possessed only small items.

In 1805 the territory of Louisiana was divided into twelve parishes: Orleans, German Coast, Acadia, Lafourche, Iberville, Point Coupee, Attakapas, Opelousas, Concordia, Rapides, Ouachita, and Natchitoches. The town of Natchitoches was the seat of the parish which included the present parishes of Caddo, Claiborne, Bossier, DeSoto, Webster, Bienville, Red River and Sabine and part of Winn, Grant and Lincoln.

The Sanchez grant at Last Tres Llanas, where Latham resided in the '20s was one of the oldest grants by Governor Lavois, who resided at Adizes. Sanches's son was 89 years old in 1820 when District Judge William Murry took testimony in the case. Later grants were made to Pierre and Julian Besson on the Ecore Rouge, and to Michael Crow on Sabine River. Crow's father (Isaac) married the widow Chabineau and purchases land of Vincente Michele, who held a Spanish grant. In 1769 St. Denys gave to his daughter, Marie, a tract of land in this area. The claim of Athanase Poisol for lands at Three Cabins, purchased from Chief Antoine of the Hyatasses Indians, was approved, as was the claim of Francis Grappe, who purchased land from the Indians of the Caddo tribe. Pierre Gagnier and Hypolite Bourdelin had bought land from the Chesteur Indians at Natchitoches. Under the Spanish regime, in 1795 Jacinto Mora was granted 207,360 acres on the east side of this land to Ed Murphy, William Burr, Samuel Davenport and L. Smith. The LaNana grant to Ed Murphy was made in 1797. It was twelve miles square and contained the present town of Many. These grants were not finally approved by the United States government until 1847.

In 1844 James Sepulvado and others bought, in partnership, five acres on Sabine River in order to become qualified voters. After Sabine Parish was created several speculators bought Spanish Land Grants. During this period Thomas Patterson, who had acquired Spanish claims, sold land to S. D. Bossier, John C. Garrett, R. A. Patterson, W. M. McCullen. The Patterson lands were on the Las Orgemas and Lanana grants and were sold to Stone & Hamlin. Stone's interests were sold to Florien Giauque, Lehmer & Pfirmen and heirs of Patterson.

Harvey Baldwin sold land to G. W. Waller, Robert McDonald, William Wilson, Jose Procella, Ephraim Butler, T. E. Boyd, Jose Rock, James Oliver, Elizabeth Roberts, Alston Nabours, W. T. Quirk, John W. Eason, Robert B. and William B. Stille. The Stilles also bought Waterman's Rio Hondo claim in 1853.

Thomas Hardin (1859), F. A. Fuller (1861). James W. Nettles (1860), and L. Barbee (1859) purchased land from the state.

Until after the Civil War Many and Ft. Jessup were the only towns in Sabine parish and they were mere villages.

THE GERMAN AND SWISS SETTLEMENTS OF COLONIAL PENNSYLVANIA by Oscar Kuhns is republished by Gale Research Co., Book Tower, Detroit Michigan 48226. It is a reprint of 1901 edition. The price is \$8.75. Order from Publisher.

This hardback book has 268 pages, a table of contents and a surname index. It deals with German and Swiss of Palitnate Country of Germany, who after the Thirty Years War and religious oppression, went first to Holland and Prussia and from there to the United States. They settled in New York, New Jersey, Virginia and Pennsylvania. They suffered many hardships in reaching this country but were industrious and the best of farmers. Here they selected the best of farmland, where the big trees grew, cleared it, and wasted no time in planting crops. In Pennsylvania, one-third of the people were of German or Dutch heritage. From these people we get the Mennonites and Pennsylvania Dutch. This is a well written book and contains much valuable information.
