

THE "VIENNA RIFLES"

Submitted by Mable H. Roberts

Formed May 1861 at Vienna, Louisiana; H. W. Perrin as Captain (transferred to the Navy, Feb 1862), J. W. Heard, 1st Lt, and A. G. Cobb, 2nd Lt. They trained at Camp Moore, Louisiana, and merged with Co. K, 2nd La. Infantry. In this Company Jim Seals was Captain and J. J. Neilson, 1st Lt (killed at Wilderness, Va., May 1864). Some of the men were in Co. C, 2nd La. Inf. (Vienna is in present day Lincoln Parish which was created in 1873 from the Parishes of Bienville, Jackson, Union, and Claiborne. Ed.)

Notes of Annie G. Parker - 18 Aug 1975: These bridges (in the following items) were first built with dirt taken from the hills by Irishmen with wheelbarrows, all but the one at Cotile near the old Red Store; this one was a dam built about 1847 to raise the water level of Cotile Bayou, which flowed out of Cotile Lake at Quadrante (now Hot Wells) and flowed on to Cotile Landing (now Boyce). Rapides Bayou joined Cotile at its mouth and flowed to Red River at Alexandria.

Both bayous' water level was used for small boats to come in and deliver supplies to stores along the way. A map in THE GENIE, Vol. VIII, No. 2, April 1974, shows the public road and stage line. Most bayous were crossed by fords. The one at Cotile, just below the dam. The Red Store, at Cotile post office, and the Philip Sleet Blue Star Grocery near McNutt Hill were just two of the popular stores on the route.

Here (in these items) we have Holt and Grogan suing to be paid for widening these bridges for traffic. The dam at Cotile went out from three days hard rain in 1886 - one negro boy drowned. We will see later in Police Jury proceedings that the milepost was at the dam.

Resolved: That the claims of James R. Andrews and Messrs Holt and Grogan be paid out of taxes of 1870, there being no estimate made at the June term to meet said claims.

To the Honorable, the President and members of the Police Jury of Parish of Rapides, Louisiana:

The petition of Mrs. Catherine Holt, Administrator of the succession of John H. Holt, deceased, and Michael A. Grogan, who resides in the parish and state aforesaid with respect shows: that in the year 1859 the Police Jury of Parish of Rapides, Louisiana, authorized and contracted your partitioners (sic) (John A.

and M. A. Grogan) to build certain bridges over the following bayous:

To the Honorable, the Police Jury of the Parish of Rapides:

Gentlemen -- Your attorney to whom you referred the claims of Messrs. Grogan and Holt against the Parish of Rapides for widening certain dams so that they could be used for the purpose of road bridges has the honor to report as follows:

Mr. Joseph W. Texada states that he was in the Police Jury in 1859, and recollects distinctly that there was a contract between these gentlemen and the Jury at that time for the bridge over Bayou Cotile and Bertrand, and that the work was done. He does not know, however, how much compensation they were to receive for the work.

Mr. Joseph H. Hynson, who was in the Jury at the same term, recollects something indistinctly about the contract.

Mr. Charles W. Boyce says there was a contract between Messrs. Grogan and Holt, and the work was done, and they were to receive \$3000.00.

Grogan, who after being duly sworn, deposes and says that the account presented by him to the Police Jury of Rapides Parish for certain dirt bridges is true and correct, and unpaid, and that there was a contract between the Police Jury of Rapides Parish and Messrs. Grogan and Holt, such as he says there was in his petition, made in 1859 at the prices charged in each separate item of the account, or at such rates as to make them separate accounts.

I have received your letter this morning asking me to make a statement in writing in regards to the Dams built by you and Holt. I know the dams were built by you and Holt and used as public bridges on the following bayous: Crosby's, Martin, Holt, Bertrand, and Cotile. These five dams were complete

and used as public bridges. I know that the dams were extended at each end further than the Government contract, by a contract made by you and Holt with the Police Jury, and they are still in use by one, that one having been cut and not washed out by water. I think I am not mistaken (that) Mr. Williams, the member from Hineston, was in the Jury at the time (it) was made in 1861-62, and he may remember something about it.

Hoping this may prove satisfactory.

Genealogically Speaking

Almost everyone, at one time or another, has the desire to recapture the pageantry and color of the distant past. Along with that desire is another to find an ancestral link with that past.

With the advent of our country's bicentennial there seems to be a renewed interest, and desire -- and one that is both stronger and more individual than an occasional nostalgia for the real or fancied romance of the past -- is that for a strong and unique identity.

One good indication of this desire is the rash of "coat-of-arms mills" that are turning out "your family coat-of-arms" at a startling rate. I'm sure that all of you, at one time or another, have received a letter written "just to you" to let you know that a coat-of-arms has been found for "your family". And, the most shocking thing is, the mills are getting rich on the nescience and gullibility of those to whom they send their letters.

Today there is a new and often justifiable pride in the consciousness of personal endeavor and individual accomplishment. So, many have felt the need to have a coat-of-arms. The fact that it might not belong to them makes little difference. They reason, "It's my name, so why shouldn't it be my arms?" The answer is simple. The arms rightfully belongs to the person to whom it was originally granted and/or who designed it. When that person dies, then the original arms passes to his heir. A similar arms, with some difference, will be borne by his other descendants; however, those descendants know who they are and are able to show and prove an unbroken pedigree back to the original owner of the arms.

Can you prove your pedigree back to the person who originally owned the coat-of-arms that you have displayed in your living room or on the cover of your family book? Be honest with yourself. Why claim something that isn't yours? Especially when you can have one that is yours! How? The same way those before us received theirs. Most were designed by themselves as a form of identification. You can do the same.

The new design becomes a valid personal symbol. And, in so establishing new arms, the bearer is establishing an heirloom instead of passing along a false one.

The most important step in developing a coat-of-arms is to decide on the character of the shield -- its shape, divisions, charges and their placement and the tinctures that will show them off to the best advantage.

There are several good books in the library on heraldry that you could use to gain ideas to create your own arms. Once you have decided upon your arms, and if you are not an artist, a good commercial artist could put your idea on canvas for you.

As an example of what you can do, I use my own arms. My father (still living) bears the arms seen at the right. The arms is described as follows:

"Argent, two bends wavy gules on a chief of the last, three estoiles or." Motto: Toujours Fort, Mais Clement

In English, this means the shield is silver with two red bends. On the chief (upper portion of the shield) are three gold, six pointed stars.

Above the shield and helmet is the crest, described as, "On a mount vert a griffin sejant or." In English: "A griffin sitting down with his forelegs erect on a mound of green earth."

Since my father is still living, I cannot bear his arms without showing a mark of cadency (order of birth). For me this would have meant placing a label in the center of the shield. Upon his death, the label would be removed. The marks of cadency placed on all my brothers' shields would remain or they could create their own arms. As indicated below, I have chosen to create my own arms.

Using my father's arms to some degree, I have changed mine as shown at the left. You will note the shield has been changed from silver to blue. Also, the three stars in the chief have been replaced by four caltraps. I also changed the motto to "God, Family, Country", and have added supporters.



The colors on my arms now are red, white and blue (our national colors). The four caltraps represent the three ancestors who fought in wars for our country (one each in the Revolutionary War, the War of 1812, the War for Southern Independence) and one for myself (Korean and Vietnam wars). The two Confederates shown as supporters represent the Confederate officers and enlisted men of my family who served the South. The motto expresses my personal priorities. The crest remains the same. In heraldic language, my arms is described:

"Azure, two bends wavy gules on a chief of the last, four caltraps, argent. Motto: God-Family-Country. Supporters: On the dexter a Confederate Officer; the sinister a Confederate Infantryman; both standing at guard. Crest: On a mount vert a griffin sejant or."

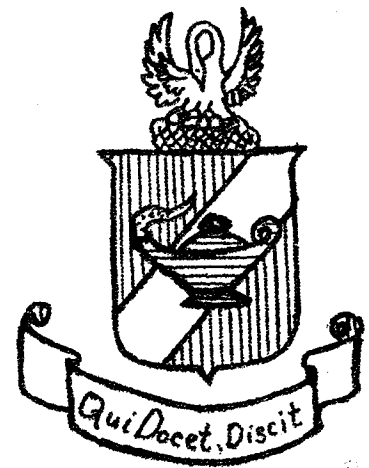
Mr. Andre Joseph Karam, a history teacher at Southwood High School in Shreveport, became interested in a coat-of-arms and, after some study, it was determined that he was not entitled to the arms of any of the Karams being touted by the arms mills.

Mr. Karam asked me to design an arms that would be his and would not belong to someone else.

Since he had no preference, the task was somewhat easy. I took three things into consideration. First, he was a teacher. What better charge on a shield could be other than the lamp of knowledge? Second, his ancestors came to this

country from Lebanon. This left two possibilities. We could use either the national colors (red and silver) or the national symbol (a cedar tree). If we used the cedar it would have had to be a charge. Since we already had a charge (lamp of knowledge) that left only the national colors. The third consideration was the fact that Mr. Karam was born in Louisiana and is still a resident in that state. What better symbol could we use than the pelican?



From all this we designed a red shield with a silver bend running from the top right side of the shield to the bottom left side. The lamp of knowledge was placed in the center of the shield. The pelican in heraldry is usually shown as a mother bird standing over her nest and feeding her young with drops of blood plucked from her breast. She is thus termed "in her piety". The pelican was selected as Mr. Karam's crest.

The result was the arms pictured above at right. In heraldic language the arms are termed:

"Gules, a bend sinister argent. On the center, lamp of knowledge, azure with flame of or. Motto: Qui Docet, Discit. Crest: A pelican in her piety".

By now it should be apparent that you, too, can design your own arms; arms that you can be more proud of than one purchased from the arms mills. Try it. You'll like it.

BOOK REVIEWS

A HISTORY OF THE TOWN OF CONCORD by Lemuel Shattuck, was first published in 1835, the town's bicentennial, and covers Concord's first 200 years. Hardcover. Order from Goodspeed's Book Shop, Inc., 18 Beacon Street, Boston, Massachusetts 02108. The price is \$10.00 per copy.

This history contains detailed information on the earliest English settlers, the Indian tribes of the area, the growth of the town, a detailed treatment of the American Revolution, Concord's ecclesiastical history, as well as the natural and topographical history of the area, and the statistical, social, and official history of Concord. Also included are chapters on the histories of the adjoining towns of Bedford, Acton, Lincoln, and Carlisle. An extremely valuable book for anyone researching early Massachusetts. It has been made even more valuable by the addition of an index to this facsimile edition.

HANDBOOK OF HERALDRY by John E. Cussans. A reprint of the 1893 edition which may be purchased from Gale Research Company, Book Tower, Detroit, Mich. 48226. Price \$15.00

This is an authoritative treatment of the subject of heraldry in which the author traces the rise of heraldry to a science and thoroughly describes each aspect of the subject. Coats of arms are addressed in depth, with entire chapters devoted to each element of their make-up. Chapters on seals, flags, genealogies, French and American heraldry, all increase both the value and interest of this very well-written book. Indexed.

WESTMORELAND COUNTY, PENNSYLVANIA, AREA KEY by Florence Clint. An 8½ x 11 inch paperback which may be ordered from Area Keys, P.O. Box 19465, Denver, CO 80219 for \$6.00 per copy.

This volume is a very complete treatment of the county designed for genealogical researchers. Each chapter is detailed and complete - listing what's available and where. Other chapters deal with census records, probate records, funeral homes (a valuable and often neglected source of information), county histories, libraries, the Federal Records Center, county formation, military records, newspapers, church records and court records. A gold mine of information for Kentucky research.

THE CIVIL WAR TAX IN LOUISIANA: 1865, with a new introduction by John Milton Price, Director, Louisiana Studies Institute. Published by Polyanthos, Inc., 811 Orleans Street, New Orleans, Louisiana 70116. A reprint containing 360 pp., the price is \$12.50.

Based on direct tax assessments of Louisianans by the federal government, this rare document is one of the few finding-aids in print for elusive ancestors during the late ante-bellum period, and the Civil War years, 1861-1865. Listed by parishes (only Calcasieu is not reported) are approximately 50,000 names of land-owners and the amount of the assessment.
